Minutes of the regular meeting of the Council of the City of Monongahela, due notice of which meeting was published according to law, held Wednesday March 9, 2016 at 7 P.M. in Council Chambers. The meeting was called to order by Councilman Caudill who led in the pledge to the flag.

Public Forum:

Carol Frye, representing the Monongahela Historical Society, asked the city for their support for allowing the Historical Society to head the celebration for the 250th anniversary of Monongahela in 2019. Councilman Miller asked for help from residents whenever there are problems at the Aquatorium, Chess Park and playgrounds by calling city hall and reporting it.

Report of Chief Tempest:

Chief Tempest informed council that the city has been given a seat belt grant through the state which will be conducted later in the month.

Councilman Kulak said it is difficult to cross some streets, specifically at 5th & Main and asked if the situation could be investigated and possibly a solution can be found.


